- 2. Mike Baber, Youth Ministry Team from Cornerstone in Pennsylvania will be here from June 23-27 to help residents with projects which need to be done around town. They will also do a Free Community BBQ on June 25th.
- MOTION BY Councilperson Witt, seconded by Councilperson Hyatt to approve a 3. donation to the Chugwater Booster Club, in the amount of \$100.00 for the calendar they put out once a year as their main fundraiser. All in favor. Motion passed unanimously.
- 4. MOTION BY Councilperson Vossler, seconded by Councilperson Witt to approve a donation to Project Safe, in the amount of \$200.00 in support of the nonprofit organization, which supports victims of abuse and sexual assault. All in favor. Motion passed unanimously.

- 2. MOTION BY Councilperson Schirmer, seconded by Councilperson Witt to sign a Pre-Paid Propane contract with Frenchman Valley Coop at \$1.72 gallon for the first amount to fill tanks up to 80%. Then at \$1.79 for amounts up to April 2015. Councilperson Hyatt abstains from the vote and would like it to go on record that he gets no commission or compensation from this contract with the Town of Chugwater. Councilperson Witt, Councilperson Vossler, Councilperson Schirmer are in favor. Motion passed.
- 3. MOTION BY Councilperson Witt, seconded by Councilperson Schirmer to approve the Malt Beverage Catering Permit for the Chugwater Chili Cook-off for June 14th at the Chugwater Town Park. All in favor. Motion passed unanimously.
- MOTION BY Councilperson Hyatt, seconded by Councilperson Vossler to approve the 3rd 4. Reading of ORDINANCE 281 concerning the appointment and filling of midterm vacancies in council seats or the mayor's office and repealing ORDINANCE 172. All in favor. Motion passed unanimously.
- MOTION BY Councilperson Schirmer, seconded by Councilperson Vossler to approve the 5. 1st Reading of ORDINANCE 283 for the Budget Year 2014-2015. All in favor. Motion passed unanimously.
- 6. MOTION BY Councilperson Schirmer, seconded by Councilperson Hyatt to pay Baker & Associates \$3550.02 for the survey that has been completed on the Town of

Chugwater's 405 Acre Property concerning the Rifle Range. All in favor. Motion passed unanimously.

New Business

- 1. MOTION BY Councilperson Schirmer, seconded by Hyatt to approve to continue paying Steve Kelley's Family medical insurance in the amount of \$215.38. Councilperson Hyatt, Councilperson Witt, Councilperson Schirmer voted yes, Councilperson Vossler voted not in favor. Motion passed.
- 2. Part-time Employees of the Town of Chugwater will not be covered by the Town of Chugwater for medical insurance.
- MOTION BY Councilperson Hyatt, seconded by councilperson Schirmer to approve 3. dumpsters from TDS for Town Cleanup June 25-27 in the amount of approximately \$2000.00. All in favor. Motion passed unanimously.
- Volunteers for the Town of Chugwater will have to be mentioned in Council Minutes 4. and sign a document stating what they are volunteering for. The document and the Meeting Minutes will then be sent to insurance so the volunteers are covered under the Town of Chugwater's insurance.
- 5. MOTION BY Councilperson Witt, seconded by Councilperson Schirmer to approve hiring a School kid for Summer Help for up to 20 hours a week and pay them between \$8-10 an hour depending on experience for the Months of June, July, and part of August. All in favor. Motion passed unanimously.
- 6. MOTION BY Councilperson Hyatt, seconded by Councilperson Witt to approve Lee Anderson to exchange town's Roto Mill for a pig to be slaughtered and cooked by him and served at the Fireman & EMT's Appreciation Picnic July 4th 2014. All in favor. Motion passed unanimously.
- MOTION BY Council person Hyatt, seconded by Councilperson Witt to approve allowing 7. Town Residents to use Roto Mill on their property, and out of town people will pay \$30 a yard/ton. All in favor. Motion passed unanimously.
- 8. MOTION BY Councilperson Hyatt, seconded by Witt to approve reimbursement from the Town of Chugwater's Fuel Tanks to Phillip Ash for the use of his loader to move Roto Mill for the Town on 3rd Street. All in favor. Motion passed unanimously.
- 9. Discussion on 18 Cement Planters given from Chevenne need to be moved to Chugwater, tabled until next meeting (June 10th at 6pm).
- MOTION BY Councilperson Schirmer, seconded by Councilperson Witt to purchase up to 10. \$1000.00 worth of plants to be distributed in the Town of Chugwater's planters. All in favor. Motion passed unanimously.
