## 6. BRC – Storage for Cook-off and Tourism

Motion made by Councilperson Marlatt to store items related to the Chili Cook-off at the BRC until such time as the BRC space is rented. Motion was seconded by Councilperson Stinnette. Councilperson Burns was opposed. Motion carried.

Small room in front 104 - \$225/month

Large room in front 116 - \$275/month

Room 106 - \$125/month

Room 107 - \$125/month

Room 108 - \$125/month

Office Suite (Rooms 113, 114, 115) – \$375

Daily rental rate for medical office - \$50 plus \$50 refundable cleaning fee.

Lease agreement (6 months), first and last month's rent, and a non-refundable cleaning/damage deposit of \$50 will be required. Requirement will be included in the lease agreement that the tenant must carry renter's insurance.

Motion made by Councilperson Stinnette to approve the above rental rate at the BRC. Motion was seconded by Councilperson Burns. All in favor. Motion carried.
