# Director of Water and Sewer Report, Lance Wedemeyer

Committees have been designated for specific departments. Lance will be working with Councilperson Cronk and Coby Romig on streets and working with Councilperson Marlatt on grounds and trees. The Governing Body hired Nicole Clark to work with Lance in his department and they have been extremely busy doing outdoor grounds keeping and organizing the shop. A detailed written report was filed and accepted by Council.

## Treasurer's Report, David Clough

Treasurer Clough reported that he is working on Covid Recovery Funds paperwork that needs to be submitted to the State. There are restrictions on how the funds can be spent. Councilperson Marlatt made a motion that David Clough be the authorized representative for the Town of Chugwater and would also like to see the list on what the funds can and cannot be used for. Councilperson Cronk seconded the motion. Motion passed unanimously.

# **Councilperson's Report**

Councilperson Cronk met with Coby Romig and Lance Wedemeyer regarding streets and future street projects. Coby will be looking into Grants and Capital Improvements will be added into the new fiscal budget to keep those expenses separate. Councilperson Marlatt stated that he purchased tools for tree trimming and pruning. The funds were approved at the prior Council Meeting and he did stay under the amount specified of \$300.

Treasurer David Clough presented the figures for the 2<sup>nd</sup> Reading of the 2021-2022 Budget. He added \$35,000 for Capital Improvements which would cover the \$30,000 expense for the Town's Emergency Siren and \$5,000 for a Water Study which our Town Engineer highly recommends and would oversee.

The title transfer for Chug Gas and Go will need further research to make sure all liens have been satisfied and Attorney Jones will file an Owners & Encumbrance Report. Councilperson Schirmer made a motion to table this until the report has been filed. Councilperson Marlatt seconded the motion. Motion passed unanimously.

Platte County Chamber of Commerce Ag Appreciation Banquet will be held on June 26, 2021. Tickets for the Banquet were included with letter received and given to Council for their consideration.

WAM Summer Convention will be held in Cheyenne on July 14, 2021-July 16, 2021. Registration forms can be submitted directly to WAM if they can attend.

Treasurer David Clough turned in his resignation effective August 31, 2021.
